SECTION IV - CONTRACT PROVISIONS

In this contract between San Jose Christian School and the parents/guardians of the student listed herein, we hereby enroll this student into the Middle School Math Tutoring Program with the following agreements:

- 1. We agree to pay the MS Math Tutoring tuition according to the payment plan selected on the reverse side. We will conclude all required payments before the last day of school.
- 2. We understand that accounts 30 days or more past due may be referred to our collection service and that unexcused delinquency in tuition payments may result in termination of enrollment in the MS Math Tutoring program.
- 3. We understand that if our child exits the MS Math Tutoring program due to a move from the area or mutual agreement by parents and staff, we will be charged the amount of tuition prorated to the quarter of the exit.
- 4. This contract may not be voided except by mutual agreement between the parents/guardians and the school. We understand this to mean that this contract will remain a binding financial obligation.
- 5. Math tutoring occurs on Wednesday and Friday mornings on which school is in session from 8:00 8:40 AM. Tardiness or missed sessions will not result in a refund or rescheduled session.
- 6. The maximum number of students enrolled per quarter will be eight students served in a cohort setting.
- 7. Students are expected to complete math homework prior to the tutoring session so that time is spent working through difficult concepts.
