Tuition Schedule

Junior K:	\$13,800/year
Kindergarten	\$13,800/year
Grades 1 – 5	\$15,100/year
Grades 6 – 8	\$16,600/year

Discounts

1. A 2% discount if total tuition paid by July 15, 2022
2. Multiple students:

First child enrolled	Full tuition
Second child enrolled	3% off child #2 tuition
Third (and subsequent) child enrolled	5% off child #3 tuition

Tuition Payment Options

Tuition may be paid in one of two ways:

1. Paid in full directly to SJCS by July 15. A 2% discount will apply.
2. Ten (10) to twelve (12) monthly payments (Beginning in July) through FACTS Management electronic payment plan.
(A \$30 fee is assessed to your bank account for each FACTS payment attempt that is denied. After a 3rd attempt is denied, your account is referred back to SJCS for collection at which time SJCS will assess additional late fees.)

Extended Day Care (School Days –3:00pm to 5:00pm; Minimum Days – Dismissal to 5:00pm or as specified)

1. Contracted Regular Use: \$9.00 per Hour
2. Late Pick-Up: \$5 for the first 5 minutes and \$5 each minute thereafter
3. Extended Care charges will be billed in arrears each month with payments to SJCS due by the 15th of the month and delinquent on the 25th of the month. A late fee of 5% of the late balance or \$5 (whichever is greater) will be applied to all delinquent accounts. Payment using FACTS Management is an option.

General Provisions

1. Families will pay the tuition according to the options stated above and will conclude all required payments before the last day of school.
2. Final tuition payment and all late fees and other charges must be made before SJCS will issue a student's June report card.
3. Accounts 30 days or more past due may be referred to our collection service.
4. Unexcused delinquency in tuition payments may result in termination of enrollment.
5. Assessments will be made to cover damage to school property (including breakage of windows, abuse or loss of books, loss of sports uniforms, etc.).
6. Application Fee, Screening Fee and Enrollment Fee are all non-refundable.
7. After enrollment, an early withdrawal of students will result in a calculation of tuition owed for time attended based on a prorated daily rate. In addition, there will be a \$100 (per student) fee for each remaining month of the school year.
8. Families grant SJCS permission to use student photos and likenesses in school-sponsored publications. First and last names will never accompany photos online or in printed publications.
9. We use a continuous enrollment policy. You will be automatically re-enrolled and charged a registration fee unless you opt out. Simply stated, when a student is admitted, they are enrolled until they graduate. Should a family choose to withdraw, written notice is required.
